- If **Glammakeupdiva Studio** is unable to perform the agreed services for any unforeseen reason or unavoidable situation, due to unforeseen circumstances or any other cause beyond her control, any and all payments shall be returned to the client with the understanding that there will be no further liability with the respect to the agreement.

- Makeup Artist will use good quality professional materials.

The remaining balance is due upon completion of services the day of wedding. Deposit is applied to the remaining balance.

Cancellation Policy

If for any reason the date and/or services are canceled by the bride, without at least a 30 days prior notice, the deposit is forfeited.

Entire Agreement
